

COMMERCIAL GARBAGE HAULER LICENSE APPLICATION PACKET

All businesses that collect solid waste or recyclable materials in the unincorporated portions of Minnehaha County must have a valid Commercial Garbage Hauler's License from the Minnehaha County Planning Department. Minnehaha County has an agreement with the city of Sioux Falls that allows citizens in the rural portions of the county to use the city's sanitary landfill. That agreement requires that the county license those haulers working in the rural parts of the county. Hauler licenses are good for up to one year and expire on December 31st of the year in which they are issued. The cost for a license is \$100. Currently licensed haulers who apply to renew their existing permit and make an application to renew by November 30th will pay a license renewal fee of only \$50. The renewal request, however, must be received in the Minnehaha County Planning office by the November 30th deadline in order to qualify for the reduced fee.

APPLICATION REQUIREMENTS

Commercial Garbage Haulers operating in unincorporated Minnehaha County must use a fee system for their customers which is based on either the volume or weight of the solid waste in order to promote waste reduction and recycling. The hauler must also provide, as a part of their service, some form of recyclable collection for the rural customers. A licensed garbage hauler is required to carry liability insurance for public liability and property damage and for bodily injury/death growing out of any one accident or any other cause in the minimum sum of \$250,000 for one person, with an annual aggregate limit of \$500,000 for two

or more persons; and in addition shall provide damage liability insurance in the minimum of \$100,000 for property damage growing out of any one accident or other cause, or as an alternative, a combined limit for bodily injury/death or property damage in the sum of \$500,000.

All vehicles used for solid waste or recycling collection shall have watertight metal boxes which can be closed to prevent the escape of materials. The box must be closed at all times when the vehicle is in motion. The hauler is also required to have at least one packer truck in good working condition. All vehicles must be specifically designed and constructed for the transport of solid waste materials and must be periodically cleaned to prevent the proliferation of disease vectors. Wood-framed, or open-framed truck boxes or pickup trucks containing dumpsters are prohibited for the hauling of solid waste or recyclables.

APPROVAL PROCESS

A list of required elements for an application for a Commercial Garbage Haulers License is located on the following page (Application Checklist).

Any incomplete application will be returned to the applicant and no license can be issued until a complete application has been received and processed by the Minnehaha County Planning Department. Once the complete application has been processed, the Planning Department staff will confirm to the applicant that they are licensed to collect and haul solid waste and recyclables within unincorporated Minnehaha County.
